Health Reform and Public Safety New Opportunities, Better Outcomes

A disproportionate number of justice-involved individuals suffer from chronic illness and/or mental health and substance abuse disorders. Many of them are unemployed young adults who earn an income well below the poverty line. Now, there is an opportunity to provide them with adequate, affordable health care by enhancing collaboration between the criminal justice and health care systems.

Early estimates indicate a significant number of justice-involved individuals may be eligible for provisions under the Patient Protection and Affordable Care Act (ACA), specifically through enrollment in Medicaid or the ability to purchase health care coverage through state health insurance exchanges. With the advent of the ACA, it is possible for millions of low-income, justice-involved individuals to obtain health care or insurance coverage for their physical and behavioral health needs. This far reaching system change will affect every decision point in the criminal justice system, from arrest to reentry.

Health Reform and Public Safety will inform audiences about ACA, highlight promising practices, and provide resources and strategies for expanding health care coverage to justice-involved individuals. During this national discussion and broadcast by the National Institute of Corrections, presenters will also:

- Establish the relevance of the Affordable Care Act to the criminal justice system.
- Provide concrete examples for collaboration and links between the criminal justice and health care systems.
- Provide health care enrollment strategies to increase informed decision-making between criminal justice and health care stakeholders.
